Minutes of the meeting held on 13th February 2023

2022/23. Present: Councillor M James (in the chair), D James, B Davies, Haynes, Pargeter, Raffan, Stacey, & C Davies. The clerk was in attendance.

- **42. Minutes of the previous meeting.** The minutes of the meeting held on 12th December 2022 were accepted and signed. Proposed Councillor B Davies. Seconded Councillor D James.

The minutes of the meeting held on 09th January 2023 were accepted and signed. Proposed Councillor Haynes. Seconded Councillor Stacey.

44. Matters arising.

i. Footpath clearing/signage – Councillor M James noted that Councillor Stacey has prepared a comprehensive document 'Llangynfelyn Footpath Maintenance' for council to consider.

The Clerk noted that council own x1 A2 copy of PRoW for the parish of Llangynfelyn.

- *ii.* Warm Hubs Councillor Stacey reported that up-take for Warm Hubs at Cletwr has improved slightly following advertisement on the Llangynfelyn community support group FB page.
- *iii.* Condition of road surface Mill Street, Tre'r Ddol. Councillor C Davies reported that this item has been added to Ceredigion County Council Highways inspector's list. Councillor C Davies also added the road from Tre-Taliesin to Llangynfelyn as reported by Councillor M James at meeting 09th January 2023.
- iv. Road safety on B4353 (Tre'r Ddol to Ynyslas). Councillor Pargeter reported that there was a recent incident by Llangynfelyn Church. The clerk reported that, following local enquiries, a car had hit the stone wall by Llangynfelyn Church and then collided with the wall of the field opposite before coming to a stop. This incident had occurred late at night, circa 12am, and police had attended. No fatality was noted.

Councillor Pargeter noted that traffic counting wires have been placed on the B4353, however the traffic volume varies considerably between winter, when caravan parks at Ynyslas & Borth are closed, and summer, when they are open. Councillor Haynes noted that traffic counting would be more accurate if the wires were placed after Easter.

Councillor M James noted that the local authority are not duty bound to consider road use unless notified by the police.

Councillor C Davies suggested council report every incident to the police through Go Safe. The clerk suggested council also keep a record of every incident reported.

Councillor C Davies will highlight problems with Ceredigion County Council Highways Officer Tom Delph-Janiurek.

v. Overflowing drain by Llanfach. The Clerk noted that the drain by the bottom of the entrance ramp to Llanfach was overflowing onto the lay-by and A487 following the meeting 09/01/2023. This was reported to Ceredigion County Council via Clic. Ceredigion County Council state that this drain should be reported to NMWTRA as the A487 is a trunk road.

Councillor M James referred to an email received from David Wyn Griffiths dated 24/01/2023 stating that he had reported the over-flowing drain to NMWTRA. Investigations on-going.

Council re-affirmed that a site meeting to include Ceredigion County Council – Keith Henson (Highways) & Eifion Jones (Footpaths), NWMTRA, Councillor M James and Councillor Haynes, Ms Deirdre Raffan, and Clerk be arranged asap.
